Across the state, everyone is feeling the magnitude of the coronavirus crisis. Below is additional information on the Governor's 11 a.m. press conference and other notable updates. 1.) Governor Whitmer announced her 'Stay Home, Stay Safe' Executive Order this morning effective 12:01 am on Tuesday, March 24, 2020.
