SUPREME COURT WON'T HEAR CHALLENGE OF GOVERNORS EMERGENCY POWERS BEFORE COA

The Michigan Supreme Court denied permission for the Republican controlled legislature to argue their case challenging Governor Whitmer's emergency powers to the Supreme Court prior to them first pleading their case to the Court of Appeals.

The Legislature and Governor Whitmer requested permission for the case to bypass the COA to expedite the process. The Michigan Supreme Court ruled in a 4-3 decision against the request because of the significance of the legal arguments and judicial rules that require the COA to consider a case before the Supreme Court.
